Notification of the change of name of the Tyndall AM entities

On Friday 12 September 2014, the Tyndall AM entities changed their name as follows:

Role	Previous	New
Responsible entity	Tyndall Asset Management Limited (Tyndall)	Nikko Asset Management Australia Limited (Nikko AM Australia)
Investment manager	Tyndall Investment Management Limited (TIML)	Nikko AM Limited (NAML)

This name change reflects that the Tyndall AM entities are part of the Nikko AM Group, Asia's premier global asset manager (with approximately AUD 178 billion in funds under management as at 30 June 2014). The purchase of the Tyndall AM entities by the Nikko AM Group took place in March 2011. Our rebrand is a result of a strategy to align the Tyndall AM entities with the other Nikko Asset Management offices internationally. Our global brand will be **Nikko Asset Management** going forward.

Notwithstanding the name change, these entities will continue to operate in their current legal structures with their existing ABNs and AFSLs. There has been no change in ownership, no change in staff and no change to our Australian office locations.

What is changing?

Although we will continue to provide the same investment opportunities and service to our investors, there will be several changes as a result of our rebrand, and it is important that you are familiar with these changes.
