BlackRock Tactical Growth Fund (PWA0822AU)

Please note that this is for your information only and no action is required from you.

BlackRock Investment Management (Australia) Limited ("BlackRock") wishes to inform you of pending changes to the existing investments and strategic benchmarks of the BlackRock Tactical Growth Fund (the "Fund"). These modifications are the result of our periodic review of the Fund's investment strategy and will take place on or after 28 February 2019.

Full details are shown in the table on the following page. The key changes are:

- A small reduction in Global Equities and Global REITs in favour of a modest increase to both Emerging Market Equities and Global Listed Infrastructure Equities
- A modest reduction in Global Fixed Interest in favour of a modest increase in Global Corporate Bonds
- Preference for a greater proportion of unhedged growth assets over hedged assets

These changes reflect our updated assessment of the opportunities in each asset class in the context of the Fund's strategic benchmark and are consistent with BlackRock's philosophy of continuously monitoring and seeking to improve investment strategies.

There are no changes to the Fund's investment objective or fees.
