**Macquarie Corporate Bond Fund – Class A Units ARSN 087 391 311 (Fund) - Risk level of Fund updated**

Macquarie Investment Management Australia Limited (**Macquarie**), the responsible entity of the Fund, would like to inform you that the risk level rating for the Fund, which is disclosed in Section 5 of the Product Disclosure Statement (**PDS**), is updated from 'Low to medium' to 'Low' effective from 26 September 2022. The risk level rating is our assessment of the potential for loss and unit price variability based on industry guidance and can require adjustment from time to time.

While there has been no change to the investment objective or investment strategy of the Fund, the Standard Risk Measure (**SRM**) calculation methodology has been updated to be consistent with Macquarie's approach. This has resulted in a change to the SRM published by the previous responsible entity of the Fund.

In addition, the revised risk level rating for the Fund is consistent with other similar Macquarie fixed income funds. You should be aware that it is not a complete assessment of all forms of investment risk and you should consider obtaining financial advice that takes into account your financial objectives and circumstances.
