- Removed BlackRock and Presima

There's no impact on management fees as a result of these changes

Why?

- The changes now fully align the manager structure in global listed property across MLC MultiActive, MLC Wholesale and MLC Pre Select.
- We believe these changes will provide a more efficient risk and return outcome, with a greater probability of achieving portfolio objectives over a full market cycle.
- We are familiar with Cohen & Steers as they are an existing manager in MultiActive.
