**Re: Changes to Nikko AM-Tyndall Share funds**

We are writing to advise that we will be changing the name of our Australian Share funds by removing the word 'Tyndall' from the name. This change is intended to be effective on or around 31 January 2017.

**Why the change?**

On 12 September 2014, Nikko Asset Management, Australia (formerly known as 'Tyndall') rebranded to align the Australian business with the global Nikko Asset Management offices. At that time, our Australian Share funds were renamed to 'Nikko AM – Tyndall' to reflect the 'Tyndall' history. As it has been over 2 years since the rebrand, it is now appropriate to remove the word 'Tyndall' from the name of these funds.

Please note this is a change of name only, and does not affect the way in which the Fund is managed or the Australian Equity Portfolio Management team.
