Reduction in wholesale management fees

Update effective: 1 April 2020

This updates the information in the MLC Wholesale Index Plus Conservative Portfolio, MLC Wholesale Index Plus Balanced Portfolio and MLC Wholesale Index Plus Growth Portfolio (collectively referred to as the MLC Wholesale Index Plus portfolios) Product Disclosure Statements (PDSs) and the MLC Investment Trust Product Guide (Product Guide) dated 1 October 2019.

From 1 April 2020, MLC Investments Limited as the responsible entity for the MLC Wholesale Index Plus portfolios has decreased the management fee as follows:
