Both the MLC Fixed Rate Funds and NAB Fixed Rate Funds invest 100% in Australian bank deposits and/or Australian bank fixed income securities, including non-NAB and NAB assets. The MLC and NAB Fixed Rate Funds aim to provide a fixed rate of interest for the term selected.

#### Who can invest in the MLC and NAB Fixed Rate Funds?

You can only invest in the MLC and NAB Fixed Rate Funds through one of the following products:

- MLC MasterKey Allocated Pension (Gold Star),
- MLC MasterKey Allocated Pension (Five Star), or
- MLC MasterKey Term Allocated Pension.

In addition, you can only invest up to 80% of your pension account in these funds. Refer to the relevant Product Disclosure Statement for further information.

## Withdrawal fee

The MLC and NAB Fixed Rate Funds have a withdrawal fee that becomes payable if you withdraw your investment before the agreed term expires. The withdrawal fee is calculated as 1% of the amount withdrawn multiplied by the remaining term divided by 365 days. The fee is deducted from your balance at the time that you withdraw the funds.
