Dear Investor,

**Regarding your investment in the Henderson Funds
(formerly the Perennial Growth Management and Perennial Fixed Interest Funds)**

On 2 June 2015 Henderson Global Investors (Australia) Limited (“Henderson”) announced the agreement to acquire Perennial Fixed Interest Partners Pty Ltd and Perennial Growth Management Pty Ltd from IOOF Holdings Ltd (“IOOF”) and the employee-shareholders of each company. As a part of the transition towards completion of these acquisitions, IOOF called a meeting of unitholders in regards to the funds listed in Appendix A (“Funds”).

At the meeting of unitholders on 28 October 2015, Henderson Global Investors (Australia) Funds Management Limited was appointed as Responsible Entity of the Funds, effective 2 November 2015.

As a result, updated product disclosure statements have been issued for the Funds, dated 2 November 2015, (“PDS”) that reflect some changes which may be of interest to you.

What is staying the same?

Importantly, the following remain the same for the Funds:

- no changes have been made to the **investment strategy or objective for the Funds**;
- the **investment teams** who are responsible for the day to day management of the Funds remain the same;
- there is no change to the **fees and expenses**; and
- there is no change to **application and redemption cut-off times and distribution frequency**.

What has changed for unit registry?

- The **name of the Funds** changed, as noted in the Appendix A.
- To align administrative and operational processes to achieve consistency in process and control, the **unit registry service** changed. New details are as follows:
