Update on the ownership of the Redpoint Global Infrastructure Fund

This updates the information in the Product Disclosure Statement (PDS) and the Product Guide dated 1 October 2019.

Antares Capital Partners Limited (ACP) is the Responsible Entity of the Redpoint Global Infrastructure Fund (Fund). Redpoint Investment Management Pty Ltd (Redpoint) is the investment manager for the Fund. ACP wishes to advise you of some changes to the ownership structure of Redpoint.

Effective 17 October 2019, the NAB Group sold its 49 per cent equity stake in Redpoint to GSFM Pty Limited. The remaining 51% of Redpoint continues to be owned by its employees, past and present.

ACP, a wholly owned member of the NAB Group, remains the Responsible Entity of the Fund.

Ganesh Suntharam has assumed the role of Chief Investment Officer (CIO) of Redpoint, replacing Eric Smith. Eric Smith will remain as an Investment Director and a member of the Redpoint board.

There has been no change to the investment process of the Fund.
