Notification of change to Legg Mason fund names and responsible entity name

We are writing to you as a unitholder in one or more funds for which Legg Mason Asset Management Australia Limited (LMAMAL, ABN 76 004 835 849, AFSL 240827) is the Responsible Entity (**Fund(s)**).

This notice is to inform you that on or around 1 October 2021, all Funds with 'Legg Mason' in the name will change to no longer include the words 'Legg Mason'.

In addition, we intend to change the name of the Responsible Entity for the Funds to Franklin Templeton Australia Limited (FTAL) on or around 1 October 2021.

Why we are making these changes

In July 2020, Franklin Templeton completed the acquisition of Legg Mason and its specialist investment managers, becoming the world's sixth largest asset manager with over A\$2.1 trillion in funds under management (as at 30 June 2021).

Due to the new company ownership, 'Legg Mason' will be removed from the fund names. The new fund names put the focus on the specialist investment managers – Brandywine Global, Franklin Templeton Investment Solutions, Martin Currie and Western Asset – who manage the portfolios. These investment teams continue to operate autonomously with specialised expertise in their respective asset classes.

Importantly, these changes will not impact how your investments are managed or the service you receive from us.

In addition, the names of the Legg Mason QS Investors Global Equity Fund and Legg Mason QS Investors Global Responsible Investment Fund are changing to reflect that QS Investors is now part of Franklin Templeton Investment Solutions. The combination of these investment groups was first announced in September 2020.

Importantly, the investment approach, strategy, and risk profile of each Fund will not change as a result of these name changes. There will be no impact on your investment.

The investment group remains well-resourced with a team of over 100 investment professionals.

Updates to fund documentation

On or around 1 October 2021, the Product Disclosure Statement (PDS) of each Fund will be amended to reflect the changes to the Funds' names.
